



## APPLICATION FOR RETIRED STATUS

Retired status may be awarded to registrants who have retired from the applied science / engineering technology profession and meet specific criteria as outlined in the Regulator’s policy. Retired does not include those who have left applied science / engineering technology profession and are working in other fields. Retired registrants are required to advise Technology Professionals Saskatchewan in writing upon returning to employment in the applied science / engineering technology profession.

A registrant who has been designated by the Board of Directors as a Retired registrant shall remit an annual fee of one-half of the annual professional fee (as stated in subsection 15.1(1)(a) Administrative Bylaws).

- \_\_\_\_\_ Should I decide to re-enter the active practice of applied science / engineering technology profession, I will immediately submit a written request to the Registrar to regain the right to practice at that time, and agree to comply with the recommendations determined by the Registration Board.
- \_\_\_\_\_ I understand that a breach of the declaration of employment status is a contravention of the Code of Ethics and Practice Guidelines and is cause for disciplinary action. The Registrar will audit, monitor, and take action as appropriate in accordance with the “*Saskatchewan Applied Science Technologists and Technicians Act*”.

## 1. RETIRED STATUS GUIDELINES

An Applied Science Technologist or Certified Technician **must** meet the following criteria to be eligible for retired status:

- a. be a current registrant who is retired from the practice of applied science / engineering technology profession **prior to December 31**;
- b. does not expect to return to the work force;
- c. the registrant's income is strictly derived from pension or investments **ONLY**;
- d. retired does not include those who have left the applied science / engineering technology profession and are working in other fields of employment or in any form of self-employment or consulting.

**NOTE: Any activities that are technological in nature, and/or any employment, self-employment, or consulting, or any similar endeavours would be considered employment and therefore not eligible for retired status.**

A request for retired status should take the form of completion of the attached application form or a letter directed to the Registrar, affirming that the applicant complies with all the criteria. Registrants are required to submit a written statement indicating the date of retirement. Once approved by the Board of Directors, the registrant will be invoiced for one-half of the current annual professional fee.

### **NOTE: PROFESSIONAL LIABILITY INSURANCE**

Technology Professionals Saskatchewan has implemented a mandatory and universal professional liability insurance program for all registrants.

Registrants that are retired or unemployed will not be covered under the Regulator's professional liability insurance program.

Registrants are required to advise the Regulator, in writing, immediately upon returning to employment in order that the appropriate insurance coverage is implemented.
